

GARAGE REGULATIONS P01

General user rules for the employee parking deck P01 of IST Austria

01. Use of the parking areas is at your own risk.
02. The maximum permissible vehicle height is shown in the entry area and must be observed.
03. The regulations of the Road Traffic Act must be strictly observed within the parking deck. In this context, traffic lights, traffic signs, information boards and floor markings must be observed, especially when parking motor vehicles.
Walking speed is permitted in the entire parking deck area.
04. Parking in the designated parking areas in the parking deck is reserved exclusively for authorized persons with an access card.
05. Connecting and pedestrian paths, lanes as well as exits and escape routes must not be obstructed by vehicles or in any other way. I.e. parking is only permitted in the designated parking areas.
06. It is not permitted to enter with a motor vehicle which's fuel system is leaking, is operated with liquid gas or hydrogen. Parking with motor vehicles without registered license plates is prohibited.
07. The use of open flames and fire, smoking and all other flammable acts are prohibited in the parking deck and adjoining rooms.
08. Flammable or explosive materials, such as fuels and liquid gas cylinders, may not be stored in parked vehicles or elsewhere in the parking deck.
09. The users are obliged to secure their parked vehicle from rolling away and to lock it.
10. Running the engines while idle is prohibited.
11. Cleaning and maintenance work on parked vehicles and refilling fuel from canisters are prohibited.
12. Any active discharge into the drainage trench is prohibited.
13. Audible warning signals in front of the parking deck entrance is allowed only in case of emergency.
14. The users of the seminar rooms and offices located on the property, as well as the users of the adjoining properties, shall be given full consideration at all times.
15. The users of the parking deck at the Campus IST Austria have to obey all regulations implemented by the management.
16. In the event of a fire, the nearest push-button alarm must be activated immediately and then an attempt must be made to extinguish the fire using the fire extinguishers provided. It is requested to contact the representatives of FM-Plus Facility Management GmbH at 0676/5706897. Persons who are not involved with the fire brigade must leave the parking deck as quickly as possible.
17. Littering on the parking deck is to be avoided. Litter may not be disposed of outside the vehicle, but rather in the designated waste bins on campus.
18. In case of loss of the access authorization card or in case of problems with the its functionality IST Austria should be contacted. During the time from 08:00h-16:30h you can reach us at 02243/9000, outside this time at 0664/88509133.
19. Damage to vehicles or structural facilities must be reported immediately to FM-Plus (0676/5706897).
20. VIDEO RECORDING, Data Processing:
The operator reserves the right to monitor areas of the garage with video cameras and record their images. Recordings that are not needed as evidence in case of specific incidents will be deleted after 72 hours at the latest. The operator is entitled to process the vehicle data obtained in the course of operation for the purposes of garage operation.
